Akkotun Tumwun Atun Osukosuk?

Kokkotun tumwun atun osukosuk a ekiek won ifa usun tumwunun safei kopwe mochen non ekkan fansoun epwe feito. Ekkei sokkun akkot a pachenong pworaus won, makkeitiw, me apworausa fengeni met mi auchea ngonuk. Ei a anisi ekkooch ar repwe sine met sokkun tumwunun safei a och ngonuk ika kose chiwen tongeni kopwe pwisin finata. Non ei sokkun napanap, emon aramas a kanengonuk epwene wisan finata fan itomw. Ei aramas sia eita ngeni emon health care agent (chon tupwunuk ren pekin tumwunun safei), a pwan iteni attorney-in-fact (emon a mwumwuta epwe tupwunuk nge esapw ii sou annuk), surrogate (chon siwinuk non och pekin), ika emon a pwung me non annuk an epwe wisan finata pekin safei.

A auchea kopwe amona ngeni ewe epwene tupwunuk non pekin safei ne apworausa ngeni met ke mochen repwe feeri fansoun ra finata ekkewe pekin tumwunun safei fan itomw.

Met ei advance directive?

Ew advance directive (taropwen tumwunun safei atun osukosuk) a nemeniom, mi wor manamanen non annuk omw makeitiw on kewe finata ren akkotun tumwun safei atun osukosuk. Kopwe apworaus ngeni ekkewe aramas ra auchea ngonuk usun omw iwe advance directive (taropwen tumwunun safei atun osukosuk)--awewe ewe a tupwunuk non pekin tumwunun safei me om famini mi auchea ngonuk--me tokter, nenien safei, me piping. Ew taropwen tumwunun safei atun osukosuk epwe asefe sefan iteiten. Meinisin mei watte ier 18 me nap seni ra tongeni amasowa ew taropwen tumwunun safei atun osukosuk.

Mi ruu sokkun taropwen tumwunun safei atun osukosuk non Washington state: 1) ewe taropwen power of attorney (taropwen mwumwutan kopwe wisen finata fan itan emon) ren pekich tumwunun safe me 2) ewe health care directive (taropwen annukun met kopwe feeri atun osukosukan tumwunun safei).

Ewe taropwen tumwunun safei atun osukosuk non ei pwuk ew durable power of attorney ika mwumwutan kopwe wisen finata fan itan emon tori an mano ren pekin tumwunun safei (DPOA-HC). Ewe DPOA-HC a anongonong won annukun Washington state (sopwun 11.125 RCW). Ei taropwe minen annuk a ngonuk mwumwutan kopwe affata io epwe wisan tupwunuk ika kapas fan itomw ika kese chiwen tongeni pwisin finata. Ei taropwe a pwan anisuk ne amona ngeni ewe a tupwunuk non pekin safei ne apworausa ngenir met kewe kopwe angang won, met ka aucheani, me met ka mochen. Ekkewe pekin kaee a pwe anemecheresin kopwe tumwunu pwe met kewe omw mochen repwe apwonaeta ren omw kopwe affata io me amona ngeni emon ewe a tupwunuk non pekin safei.

Ewe taropwen tumwunun safei atun osukosuk non ei pwuk esapw ew taropwen tumwunun safei (health care directives). Ewe taropwen tumwunun safei (health care directives) a pwan iteni living will ika met omw mochen atun om manaw. Ka tongeni kopwe pwan ekieki om kopwe amasow eche taropwen tumwunun safei (health care directives), ei a ew annukun kopwe angei sefani ika amwochu ekkewe tumwunun safen epwe atamano manaw non ekkooch wewe me non annukun Washington state. Ren pwan ekkooch pworaus won taropwen tumwunun safei (health care directives), katon: www.HonoringChoicesPNW.org ika pworaus ngeni noumw iwe tokter.

Met ei health care agent?

Emon health care agent is ewe aramas ka finata epwe siwinuk/tupwunuk ne finata omw tumwunun safei ika kose chiwen tongeni finata won pwisin en. Kopwe ereni ewe a tupwunuk non pekin safei met mi auchea ngonuk, ren metekewe ka aucheani me met oupwe angang ngeni ren pekin tumwunun safei. Ei pworaus a tongeni emweni ewe a tupwunuk non pekin safei me tokter ar repwe finata met a och, fan itomw ika pwe kose chiwen tongeni pwisin finata met epwe fis. Omw ei ka awesano ei annukun tumwun atun osukosuk (advance directive) (mwumwutan kopwe wisen finata fan itan emon tori an mano ren pekin tumwunun safei) ka mwut ngeni ei aramas epwe finata fengen me noumw kewe tokter usun omw tumwun. Ewe a tupwunuk non pekin safei esapw wiseni meeni omw tumwun nge ra finita fan itomw repwe tupwunuk non pekin safei.

Met a feeri an emon epwe emon chon tupwunuk non pekin safei epwe och?

Noumw we chon tupwunuk non pekin safei EPWE:

- ✓ Weweiti met chon tupwuni emon non pekin safei (health care agent) ekan feeri me mochen epwe wiseni ei wis.
- ✓ Apworausa metekewe kopwe angang won, met mi auchea ngonuk, me met omw mochen ngeni noumw tokter, me anapanapa met wewen ewe "nonomw mwurine" ika ew "ran mi och" ngonuk.
- ✓ Feeri metekewe omw finata, ika mo pwe esapw mese fengen me omw pwisin finata.
- ✓ Tongeni finata non fansoun mi aweires ika osukosuk.

Ewe a tupwunuk non pekin safei (health care agent) ESE TONGENI epwe:

- ✗ Kukun seni 18 ierin.
- ✗ Noumw we tokter ika neun nomw we tokter chon angang (chinon chok ika ir pwunuwom, chienomw mi rechister me non ewe state, saam me iinn, noumw mi watte, ika pwium/mongeom e watte).
- ✗ Ewe owner (io an ewe neni), chon amweni, ika emon chon angangen ewe nenien tumwunun safei ika nenien tumwun non fansoun nangatam ka angei omw tumwun me ie ika nomw (chinon chok ir pwunuwom, chienomw mi rechister non state, saam me iinn, noumw mi watte, ika pwium/mongeom e watte).



Met ewe health care agent epwe feeri?

Ika kose tongeni pwisin finata omw tumwunun safei, ewe a tupwunuk ren pekin safei (health care agent) epwene wisen finata omw tumwun fan itomw. Ewe epwe tupwunuk ren pekin safei (health care agent) atongeni eaea ekkewe pworaus ka apworausa non ei annukun tumwun atun osukosuk (advance directive) me non ekkooch pwopworaus fengen an epwe emweni ren omw tumwun.

Epwe nene ngeni ekkewe annukun state me eaea ar weweti metekewe kopwe angang ngeni, met a auchea ngonuk, me met ka mochen, ewe epwe tupwunuk a tongeni:

- Finata ekkewe tumwunun safei me reierei, pachenong ika epwe pwan angasangas (CPR), ewe mwesinan angasangas, ew paipen amwongo, me ekkooch pwan tumwunun safei.
- Finata ika epwe aukanu ewe tumwun ren life-support me tumwunu chok ren kinamean.
- Nengeniochu me atou ekkwe taropwen safei en mi anoumw ika apply ngeni aninisin inuransin safei fan itomw.
- CFini ewe tokter me neni epwe awora ngonuk tumwunun safei.

Met ei CPR?

Aninisin angasangas (Cardiopulmonary resuscitation ika CPR ie ew angang sa eaea atun ngasangasomw me omw ngasangas a kouno. CPR ekan och ika pwe inisum mi pechokun me CPR a pwopwuta mwirin chok an ngasangasomw a kouno. CPR ina esapw kon och ika pwe en mi apwangapwang, chinap ika mi chou omw semwen.

Ika kopwe manaw, in kopwe eae ew ventilator (mwesinen angasangas) pwokiten ammatomw mi apwangang. Mi auchea kopwe pworaus ngeni noumw tokter won ika CPR epwe nomw non metekewe kopwe angang ngeni (goals).

Tumwun non Washington state a kan awora CPR ngeni aramas ika ngasanger me ar ngasangas a kouno. Apworuasa ngeni kich omw mochen ren CPR won ei taropwen DPOA-HC a tongeni emweni omw "code status" ika nomwono non pioing. Wewen code status ewe sokkun tumwun atun osukosuk emon aramas epwe angei ika esapw angei me non pioing ika ngasangasan ika an ngasangas a kouno.

Ekkooch aramas ra fini pwe repwe angei CPR non pioing me rese mochen CPR pwan non ekkooch neni. Non ei sokkun kopwe eisini noumw iwe tokter kopwe amasowa ewe Orterin Safei Repwe Eaea Fansoun Osukosuken ewe mi semwen (Portable Orders for Life-Sustaining Treatment (POLST)). POLST ie ewe orterin safei ewe a affata ekkewe finata ren pekin tumwunun safei atun emerechensi ekkewe ra keke ngeni ewe osukosuk me ekkooch chon angangen pioing.

Met ei life support (aninisin manaw)?

Life-support (a pwan iteni life sustaining ika atamano manaw) tumwun ikkei ekkei tumwunun safei a amanawok ane epwe anisi ika siwini ekkewe auchean wisan/angangen inis (inisich). Ekkei tumwunun safei ese achikara ewe semwen. Ra amanawok tori an kopwe pechokun ika ra angei sonuk ewe life support (aninisin manaw) me ka pwisin mano. Ekkooch awewen ekkei tumwunun safei epwe anisi manawomw ekkewe CPR, mwesinen angasangas, paip sa amwonganuk me non, angang/eaea cha seni emon, me kidney dialysis (nimmen omw kipwin). A auchea kopwe sine pwe ekkinamwein metek me ach awora kinamwe ikkei kinikinin ewe tumwun me esapw ikkei tumwunun atamano manaw.



Met epwe fis ika use affata io epwe tupwunuei non pekin safei (emon health care agent)?

Ika kose tongeni pwisin finata omw tumwunun safei me emon chon tupwunuk non pekin safei ese affat, noumw kewe tokter repwe fiti pwungun annukun Washington state ar repwe apwungano io epwe wiseni finata fan itomw ren pekin safei. Wewen ei repwene eisini chon famini ika chiechiomw ar repwe finata ekkewe pekin safei fan itomw. Ika famini ika chiechomw sise tongen sipwe sine seni ei teten fan, ekkewe tokter repwene eisini kapwung an epwe finata emon chon tumwun (guardian) an epwe wisani finata pekin safei fan itomw.

Ekkewe tokter repwe kekeri ekkei aramas non ei teten tori epwe repwe fat won emon chon fintata ren pekin safei fan itomw (sopwun 7.70.065 RCW).

1. Emon chon tumwun (guardian) a finita seni kapwung (ika epwe tufich)
2. Ewe epwene tupwunuk ren pekin safei (health care agent) usun mi afatafat.*
3. Pwunuwom ika chienom mi rechister itan.
4. Noumw ra watte*
5. Saam ika iin*
6. Pwium/mwongeomw mi watte*
7. Noumw kewe noun noumw mi watte ra sineok ewe chon semwen*
8. Tetenin noun nengin me at ekkewe ir mi sineok ewe chon semwen*
9. Tetenin inomw me sememw ra watte ir mi sineok ewe chon semwe n
10. Emon chiechiom mi watte mi kan ngonuk epwe tufich ngeni ekkei criteria.

Met ekkooch wewe epwe weneiti?

Affata pwunuwom pwe iei chon tupwunuk won pekin tumwunun safei (health care agent).

Ika ke fini pwunuwom iwe ika emon chienomw mi rechister itan pwe epwe emon chon tupwunuk non pekin tumwunun safei won ei taropwe, repwe chok kouno ar tupwunuk ren pekin tumwunun safei ika chok pwe kopwe faenuni an epwe eukanon manamanen, annulment (mwuchunon manamanen), ika keimwufesen me non annuk (legal separation) (sopwun 11.125.100 RCW). Ei taropwe a mwutata kopwe finata an epwe sopwosopwono repwe chon tupwunuk re pekin tumwunun safei, ika mwo mwirin divorce (mwu fes).

Ika ei wewe epwe weneituk, makei nepwopwutan itomw won ei taropwe non Peich 1: "Ika uwa affat pwunuwei we ika chienei we mei rechister pwe repwe tupwunie ren pekin tumwunun safei me mwirin faenuni taropwen epwe eukanon manamanen, annulment (mwuchunon manamanen), ika keimwufesen me non annuk (legal separation); Uwa mochen repwe sopwosopwono ne tupwunie ren pekin tumwunun safei."

Omw kosapw affata emon chon tupwunuk ren pekin tumwunun safei non ei taropwe

Ewe auchean met epwe fis me non ei taropwe an sipwe affata emon epwe tupwunuk ren pekin tumwunun safei, ka pwan tongeni finata pwe esapw wor emon. Ika kose affata emon epwe tupwunuk ren pekin tumwunun safei, ekkewe tokter repwe fiti pwungun annukun Washington state ne apwungano io epwe tongeni wiseni finata ren pekin safei fan itomw.

Ika ka amasowano ekkewe ekkooch kinikin non ei taropwe, sipwene era pwe ie omw pworaus ren met mi auchea ngonuk me esapw ew advance directive (annukun tumwun atun osukosuk). Eche taropwen omw pworaus ren met mi auchea ngonuk iei mennapen metekewe kopwe angang ngeni, met ka aucheani, me met ka mochen. Ei pworaus a tongeni epwe emweni noumw we chon finata ren pekin safei won an epwe finata ren pekin safei fan itomw.

Ika ei wewe ese weneituk, makkei nepwopwutan itomw won ei taropwe won Peich 1: "Ngang use affata emon epwe tupwunie ren pekin tumwunun safei. Ai apworausa metekewe uwa angang ngeni me aucheani won ei taropwe, epwene iei ai pworaus won met a aucheana ngeni ei nge esapw ew advance directive (annukun tumwun atun osukosuk)."

Non ei wewe, ka tongeni pwan amasowa ew health care directive (annukun tumwunun safei), a pwan iteni living will (met ka mochen fansoun omw manaw), ewe epwene annukatiw an kopwe angeisefani ika amwochu ekkewe tumwunun atamano mana non ekkooch wewe fan pechokunen annukun Washington state. Ren pwan ekkooch pworaus, katon www.HonoringChoicesPNW.org ika pworaus ngeni noumw iwe tokter.

Met upwe feeri ngeni ei advance directive (annukun tumwun fansoun osukosuk)?

Fanoun ka awesano ei advance directive (annukun tumwun atun osukosuk), kopwe pworaus ngeni ekkewe aramas ra auchea ngonuk won omw mochen me ngenir kapin—awewe ewe chon tupwunuk ren pekin tumwunun safei ika emon chon om famini—me noumw tokter, nenien safei, me pioing. Ika epwe weneiti, kowpe pwan ngeni omw iwe nursing home ika nenien aninis kapin ei taropwe. A auchea an meinisin epwe wor nour kapi.

Nge ika uwa siwini ai ekiek?

Ika ka siwin omw ekiek won met ka finata non omw iwe advance directive (annukun tumwun atun osukosuk), ereni meinisin mi wor nour kapi, pachenong noumw iwe chon tupwunuk ren pekin safei, famini, tokter, nenien safei me pioing. Ka tongeni angei sefani ika eukano manamanen ewe advance directive inetuchok ka mochen. A auchea kopwe ereni noumw iwe tokter pwe ka mochen angei sefani (kansenini manamanen) om kopwe makkei ngeni eche taropwe (tumwun omw kopwe saini me makkei pwinin maram won) ika fen pwisin erenir. Mi auchea kopwe amasowa eche minafen advance directive. Kopwe ngeni ekkewe aramas ra auchea ngonuk kapin ei minafen advance directive—awewe ewe a tupwunuk ren pekin safei—me noumw tokter, nenien safei, me pioing.

Penuweni Ekkewe Tungorun Niffang ren pisekin non inisich (Organ/tissue donation):

Ika ke mochen kopwe emon donor (kopwe ngeni ekkooch pisekin inisumw), kose mochen ereni ewe a tupwunuk ren pekin safei, famini, me tokter. Ka tongeni pwan makkei ekkewe pisekisekin non inisumw me mesomw ka mochen niffangono won www.registerme.org.

Io epwe finata eae an inisi mwirin uwa mano?

Ei taropwe esapw affata eaea/poutunon inis mwirin mano. Kopwe sinei pwe omw amasowano eche taropwe ewe epwe awora met epwe feer ngeni inisumw mwurin omw mano epwe pwung me non annukun state (sopwun 68.50.160 RCW).
